Welcome to the Hudson Raider Shooting Club, Inc.'s (HRSCI) 2022 Shooting Season!

We're happy to have you as one of our trap team members! Trap is our main discipline which we require you to shoot when joining the team. We also offer Skeet, Sporting Clays, and Pistol/Rifle disciplines. Our coaching staff is here to make sure you develop new skills, improve your shooting abilities, and gain self-confidence. We're confident this will create new friendships, reconnect with old ones, and most of all be fun!

#### MISSION STATEMENT

The Hudson Raider Shooting Club will provide, promote and perpetuate opportunities for young athletes to develop character and personal growth through safe, supportive, educational and socially acceptable involvement in the shooting sports. This organization strives to promote the highest standards of safety, sportsmanship, teamwork and ethical behavior with a focus on the safe handling and use of firearms. Participation is a privilege, not a right.

#### **REGISTRATION FEES**

Fees to participate with the HRSCI must be submitted at the time of enrollment. The fees required are needed to secure:

Shooting ranges/courses Competitions

Shooting fees Uniforms

Membership in the WI SCTP/SASP league, ATA, and NSCA/NSSA

Administrative costs: training, background checks and insurance

HRSCI must commit to an accurate participant count to our host range, therefore, the team has a no-refund policy for all fees.

#### **ATHLETE ACCOUNTS**

Each athlete has a personal account and/or family account if more than one child is participating. For any team fundraising effort, athletes may be awarded a percentage of any proceeds to be placed in their account. This credit will be placed in their personal accounts to be used for the purchase of shotshells, tournament fees, jerseys, etc. (or other as may be approved by the board of directors). A portion of any proceeds may, at the discretion of the team's board of directors, be used for team expenditures as listed under Registration Fees as well as any other expenditures to hold and support the fundraiser.

#### CARRY OVER, RETURN, OR RELINQUISHMENT OF ATHLETE ACCOUNTS

If you have remaining money in your account at the end of the season that has been earned under any team fundraising activity or event, these funds can be left in your account and carried over until the following season. Wisconsin State Statutes prevent any cash refunds by a non-stock, non-profit, tax-exempt organization such as the HRSCI. If you are an athlete who is not returning to the team, you may request to return the value of your account in the form of boxes/cases of shotshells at the current team replacement costing value. Requests for reimbursement should be made in writing to the HRSCI board within 10 business days of the conclusion of your last participation in any of the team's current season ending conference or tournament play. If you do not provide a request to return the value of funds in your account, those funds may, at the team's discretion remain in the athlete's account until the athlete graduates from high school or otherwise be automatically forfeited to the general team account for general team expenditures. The policy of the HRSCI will be that of a "use it or lose it" principle.

#### **OBLIGATION AND AGREEMENT TO PAY DEBT**

As a parent of an athlete with the HRSCI, I agree that I have an obligation to pay all debt incurred by myself or my child(ren). I agree to pay the debt upon request by HRSCI and further agree to pay any and all legal filing fees, interest and attorney's fees incurred by the HRSCI in an effort to collect payment on outstanding debt.

#### SCHOLASTIC SHOOTING SPORTS FOUNDATION (SSSF)

The Hudson Raider Shooting Club, Inc., falls under the oversight of the SSSF which is the national governing body for the SCTP and SASP. As such, parent and athlete, agree to follow and abide by all rules, polices and guidelines as set forth by the SSSF.

#### **HOLD HARMLESS**

In consideration for receiving permission to participate in the activities of the Hudson Raider Shooting Club Inc. (HRSCI), I, for myself and my minor child, hereby release, waive, discharge and indemnify HRSCI and its members or agents ("Releasees") from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, injury, or death that may be sustained by me, or my minor child, while participating in any HRSCI team activities, whether caused by the negligence of the Releasees or otherwise.

I am fully aware of the risks involved and the hazards connected with the Hudson Raider Shooting Club's team activities, including the risk of injury or death. I, or my minor child, elect to voluntarily participate in these activities with full knowledge that they may be hazardous. I and/or my minor child, voluntarily assume the risk of loss, property damage, personal injury, and/or death that may be sustained by me, my minor child, or my heirs and assigns as a result of my, or my minor child, engaging in such activities, whether caused by the negligence of Releasees or otherwise.

I further hereby agree to indemnify, defend, and hold harmless the Releasees from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my, or my minor child, participating in HRSCI team activities, whether caused by the contributory negligence of Releasees or otherwise.
