


Integrity, Respect, Responsibility



Being a member of the Hudson Raider Shooting Club is a privilege which is accompanied by student and parent responsibilities. A violation of the Code of Conduct may result in a period of ineligibility, removal from an activity or event, or expulsion from the team.

### **Students and Parents agree to the following:**

- ❖ You must follow all of the rules as outlined by the Wisconsin Scholastic Clay Target Program (SCTP), Hudson Raider Shooting Club, and any gun club or shooting range at which the team shoots.
- ❖ You will be respectful of all fellow team members and coaching staff at all times, and represent the team with pride and integrity whenever participating in a league event or team activity.
- ❖ You are required to purchase, maintain, and wear the assigned Club's uniform anytime that you are competing with the team or while attending any Club or league event unless otherwise directed by the Club's leadership.
- ❖ You will respect the Coaches and follow their direction. You understand that you need to follow this direction especially during our League events at all times for safety reasons to protect all Athletes, Coaches, Volunteers and Spectators.
- ❖ You promise to make Safety the Number One Priority whenever you are handling a firearm.
- ❖ All members of the team will display exceptional sportsmanship at all competitions and team activities. Students and parents will avoid offensive gestures or language, accept decisions of contest officials, and display modesty in victory and graciousness in defeat.
- ❖ All members of the Club shall respect the rights, beliefs, and property of others and treat others with courtesy and consideration.
- ❖ Students and parents will communicate openly, honestly, and respectfully with coaches, officials, and volunteers. Open and respectful communication with the coaches is encouraged when it becomes necessary to clarify our decision-making process.



### **What does this mean in simple terms?**

- **Follow the rules**
- **Don't heckle, bully, trash talk, swear, throw a temper tantrum, or be disobedient of directions from coaching staff**
- **Proudly wear the required uniform and represent yourself as a RAIDER!**
- **Follow directions**
- **Safety is the #1 priority**
- **Be kind to one another. Show support and encouragement; don't say things that put people down. Communicate openly, honestly, and respectfully with all**
- **Treat others as you would like to be treated**


### Students and Parents agree to the following:

- ❖ All members of the Club are strictly prohibited from using, purchasing, possessing, selling, distributing or manufacturing any illicit or illegal drugs or chemicals.
- ❖ All members of the Club are strictly prohibited from using, possessing or being under the influence of any alcoholic or intoxicating beverages and tobacco, tobacco products, e-cigarette and e-cigarette devices at any Club or Team facility, function, meeting, competition, practice or other team activities.
- ❖ All members of the Club shall be fully responsible for their own actions and the consequences of those actions.
- ❖ Any misuse or violation of these rules could result in suspension of your shooting privileges with the team including up to permanent removal from the team's roster.

### Violations of the Code of Conduct

Disciplinary actions for any code of conduct violations will be dealt with by the Hudson Raider Shooting Club, Inc.'s coaching staff. Disciplinary decisions will be made by a minimum of two coaches in conjunction with the head coach. Their decisions are final and not appealable. Disciplinary decisions will be discussed with the student athlete(s) and their parent(s) or guardian(s) by the coaching staff and may include:

- ❖ Verbal discussion with the student athlete(s) about the unacceptable behavior
- ❖ Immediate removal from the shooting line and possible club grounds
- ❖ Removal from any and all shooting events (including conference, tournament, state and national shooting events)
- ❖ Suspension from the team for a determined period of time
- ❖ Permanent expulsion from the team




- **Don't do drugs; don't purchase drugs; don't possess or sell drugs**
- **Don't drink, smoke, or vape**
- **Represent your team and yourself with pride**
- **Be responsible for your actions as you will be held accountable for them**
- **Make good decisions to avoid suspension or removal from the team**
- **You are all valuable members of our team. Make friends, encourage one another and HAVE FUN!**
- **Violations of the Code of Conduct will result in possible suspension, removal, or expulsion from Club activities, competitions, or the team itself.**

## **Violations of the Code of Conduct – cont'd**

Student athletes that are removed from the shooting line shall receive a score of 0 (zero) for all rounds: in progress, already completed or yet to be shot, for the event(s) in which the violation occurred.

Student athletes that are suspended or expelled from the team shall forfeit all shooting fees paid and/or owed as well as paying any remaining balance that is owed on the student athlete's account. The student athlete and their parent(s) or guardian(s) agree to pay the entire remaining balance immediately upon request by the HRSCI. Additionally, in the event of permanent expulsion from the team, any remaining funding in the student athlete's account shall be forfeited to the Club and distributed to the Club's general account for use by the Club.

Reinstatement to the Shooting Club is at the discretion of the head coach after consultation and agreement with the coaching staff and will require a face-to-face meeting with the head coach, a minimum of one assistant coach, the student athlete and the student athlete's parent(s) or guardian(s).

By signing this form, the student athlete and their parent(s) or guardian(s) hereby acknowledge, authorize and agree to pay any and all filing fees, including reasonable attorney's fees, incurred by the HRSCI to recover or attempt to recover any dues, fees or payments owed to the HRSCI.

## Photo Release
