<p>While each shooter is covered by a very sound SCTP insurance policy, Shooter/Legal Guardian still has to assume responsibility for any exposure or risk of COVID-19 related illness, bodily injury, death, emotional injury or property damage whether due to the active or passive negligence of another participant, or any other person while being instructed/coached, shooting or observing others shoot, or any other activity while participating at Raider sponsored practice or shooting event. Shooter/Legal Guardian agrees that this waiver and release from liability agreement is intended to be as broad and as inclusive as permitted by law and if any portion of this agreement is held invalid, the balance of the agreement shall continue in full legal force and effect. Parents/Guardians must assume and accept at their own assessment of risk as to if their shooter should participate in any shooting practices or competitive events.</p>	
<p>Shooters/Guardians will comply with the current HRST prevention measures while on-site during shooting including:</p> <ul style="list-style-type: none"> • Not having any physical contact with any person, such as shaking hands without proper protection • Maintaining 6 feet distance from all persons when at all possible • Sneezing or coughing into a tissue or bent arm • Leaving the grounds immediately if you develop sickness, fever, cough, sore throat, or difficulty breathing • Letting coaches know you are leaving the grounds if not feeling well <p>Raider Coaches and Staff will provide for the following minimum precautions:</p> <ul style="list-style-type: none"> • Wear personal protective masks as may be needed • Wear latex gloves as may be needed • Always be in a mindful state and take precautions to the best of their ability and as advised by local jurisdiction to protect shooters and themselves from the potential of getting or spreading the Covid-19 virus
